Which accumulator batteries are included in the cabinets covered by the technical specification?

The cabinets covered by the technical specification have been designed to contain the hermetic lead-acid electric accumulator batteries.

Where can I find a UL certified battery containment enclosure?

Battery containment enclosures certified by UL Solutions to UL 1487 can be found in the online certification directory, UL Product iQ<sup>®</sup>. Product iQ is available to use at no cost but requires a one-time registration.

What are battery containment products?

In addition to these prevention strategies, battery containment products have emerged which are purpose-built for mitigation of thermal runaway hazards of lithium-ion batteries and battery-powered devices that are stored and charged inside of them. UL 1487, Battery Containment Enclosures, was created to evaluate these products.

What are the NFPA requirements for a battery system?

The battery system must follow the current National Electrical Code requirements: NFPA 855, "Standard for the Installation of Stationary Energy Storage Systems". The battery cell complies with UL 1642, "Standard for Lithium Batteries". The battery module complies with UL 1973, "Batteries for Use in Light Electric Rail Applications and Stationary Applications".
