There are two main government agencies responsible for attracting foreign investment, the Export and Investment Center of the Dominican Republic (CEI-RD) and the National Council of Free Trade Zones for Export (CNZFE).

Incentives typically take the form of preferential tax rates or exemptions, preferential interest rates or access to finance, or preferential customs treatment.

Does the Dominican Republic have a bilateral investment agreement?

The agreement entered into force by Congressional Resolution No. 178-01. The Dominican Republic has entered into 12 bilateral investment treaties that are in force, most of which contain dispute resolution provisions that submit the parties to arbitration.
