Who should perform spot checks?

Spot checks should be performed by experienced staff, Safety Officers and Operational Managers who are authorised to enter the area. HSRs should also be invited to participate in Spot Checks. Findings and actions that arise from workplace inspections and spot checks must be recorded in SARAH+.

What are the inspection requirements for a worksite?

Every worksite is unique, and specific inspection requirements may vary based on individual industry practices, regulations, and site conditions. Users of this template are encouraged to review and customize the checklist to align with their specific site environment, project needs, and safety protocols.

What is a spot check?

Spot checks are an opportunity to focus on a specific issue or compliance requirement. For example, you may want to check on a specific type of equipment, or check that electrical testing and tagging has been done, or check that all decanted chemicals are labelled correctly.

What is a construction closeout inspection?

Quality inspection - Quality inspections verify work, materials, and adherence to standards. They're designed to make sure the finished product meets expectations. Final closeout inspection - Final construction closeout inspections provide the last check before handover. They confirm all work is complete and ready for client approval.

Provide clear, agreed upon, and safe signals to the MEWP operator. Coordinate pedestrians and site traffic with MEWP operations. Direct the movement of machines and persons within MEWP operations.

Spot checking, on an individual practice, is not to be done by anyone who determined need, provided technical assistance during construction, made the construction check, or certified performance.
